If you've served in the military or know someone who has you'll understand why SAFE Veterans (a SAFE Project initiative) is close to our hearts. A veteran is twice as likely to die from an accidental overdose than any other member of society, and for veterans and their families, the transition to civilian life can be particularly difficult, often losing the sense of purpose, camaraderie, and identity central to their military experience. Military culture also values self-reliance, which can lead to the perception that "getting help" is a weakness.

The need: Few prevention programs address this concern and prepare the service member or their family with tools to prevent substance use disorders or mental health conditions.

To address this gap, SAFE Veterans developed and expanded several programs to connect veterans, active duty service members, and their families to the resources they need to address mental health challenges and substance use disorders.

The State of Pennsylvania hosts nearly 1 million veterans and their families. The state strives to provide quality care to all veterans. There are a wide range of federal, state, and county benefits available to qualified veterans and their families.

One of the nation's most iconic cities, Philadelphia, has been important for the U.S. military since the forming of the nation. The city is home to the Liberty Bell and hosted the site of the signing of the Declaration of Independence. Philadelphia, the "City of Brotherly Love," continues to encompass a large portion of the veteran population in the state. Philadelphia veterans have access to a list of benefits and support earned by their service to the country. The benefits range from health services, housing assistance, and psychological help, along with employment/networking opportunities.

MILITARY DEPENDENTS

The term "military families" often refers to the spouses, children and adult dependents of active duty, National Guard and Reserve Component service members. According to the most recent U.S. Department of Defense (DOD) Demographics Report, there are 2.6 million military family members and almost 39% of military personnel have minor children (under 20 or 22 and full-time student).

The VA was formally established in 1930 and became the cabinet-level Department of Veterans Affairs in 1989. The agency is led by the Secretary of Veterans Affairs with the advice and consent of the Senate.

Pennsylvania "Operation Recognition" Diplomas: "Operation Recognition" is a state law that authorizes school districts to grant a high school diploma to any honorably discharged veteran who served in the United States military during World War II, the Korean Conflict and the Vietnam War.



• How to apply: To be awarded through Operation Recognition, interested veterans should submit proof of their honorary discharge from the armed services and proof they were a student in either PA high schools during the times specified for either World War II, the Korean War, or the Vietnam War, to the Superintendent's Office. The Superintendent's Office will verify applicants' status as a student during the years specified for military services. Contact your local Superintendent's Office for more information.

Pennsylvania Postsecondary Educational Gratuity Program: This program honors individuals who lost their lives protecting the citizens of Pennsylvania by helping their children fund their education. The Postsecondary Educational Gratuity Program (PEGP) provides a waiver for tuition, fees and on-campus room and board costs charged by public postsecondary institutions. This waiver applies only to charges that remain after all other grants (federal, state and outside scholarships) have been applied to the student's account.

Pennsylvania Interstate Compact on Educational Opportunity for Military Children: It is the purpose of this compact to remove barriers to educational success imposed on children of military families because of frequent moves and deployment of their parents by:

 Facilitating the timely enrollment of children of military families and ensuring that they are not placed at a disadvantage due to difficulty in the transfer of educational records from the previous school district or variations in entrance or age requirements.

6. PA Financial Assistance

PA Property Tax Exemption: A disabled veteran in Pennsylvania may receive a full property tax exemption on his/her primary residence if the veteran is 100 percent disabled (total and permanent) as a result of wartime service. To be eligible a veteran must prove financial need, which according to the state is income less than \$92,594. Veterans whose income exceeds that value may still be eligible.

Veterans Emergency Assistance: Provides financial aid in an emergency and temporary basis (not to exceed three months in a 12-month period) to veterans, their widows, infant children or dependents who reside in Pennsylvania for the necessities of life (food, dairy, shelter, fuel and clothing). An honorably discharged veteran must have served in the Armed Forces of the United States during established war service dates or during peacetime hostile fire or terrorist attack as determined by the Department of Military and Veterans Affairs. Upon the recent death of a veteran, his widow or orphan children are eligible provided the veteran would have qualified prior to his/her death.

Blind Veterans Pension: Provides for a pension of \$150.00 per month for a person who served in the military or naval forces of the United States, or women's organization officially connected therewith, who gave the commonwealth as his/her place of residence when entering the military and while performing duties connected with the service, suffered an injury or incurred a disease which resulted in loss of vision. Provides for a pension of \$150.00 per month for any person separated under honorable conditions from the Armed Forces of the United States, who gave the Commonwealth of Pennsylvania as his or her place of residence at time of entering the military or naval forces of the United States and who currently resides in Pennsylvania.

Paralyzed Veterans Pension: A pension of \$150.00 per month for honorably discharged veterans who suffered a service connected injury or disease which resulted in the loss or loss of use of two or more extremities (arms/hands or legs/feet).

In addition, they are entitled to an unpaid leave of absence from their respective duties without loss of seniority or efficiency rating on all days in excess of 15 days per year during which they shall be engaged in training or other military duty under orders authorized by Federal or State law.

Pennsylvania Employee Re-employment following Emergency or Military Duty: Upon completion of emergency or military duty, any member of the Pennsylvania National Guard or any other Reserve component of the U.S. Armed Forces shall be restored by his/her employer to their previous employment position and status, or a position of similar seniority, status and pay which was held prior to the service member's deployment or mobilization. If the service member is not qualified to perform the duties of such position due to disability sustained during mobilization or deployment, but otherwise qualified to perform the duties of any other position in the employ of his/her former employer, then a position in which he/she is qualified to perform with like seniority and pay (or the closest approximation thereof consistent with the case) shall be offered.
