



# Training of Trainers

## Integrated-Forensic Peer Recovery Specialist (i-FPRS)

### OVERVIEW:

#### I-FPRS TRAINING OF TRAINERS

The i-FPRS Training of Trainers (ToT) is primarily geared towards larger organizations, multiple organizations within a state, and state agencies.

The i-FPRS ToT equips participants with the knowledge, skills, and abilities to train Certified Peer Recovery Specialists in navigating the complexities associated with the cross-section of behavioral health and criminal justice service settings.

This training provides i-FPRS facilitators with expertise and knowledge, partnered with their experiences, to teach peers how to assist justice-involved individuals in addressing the barriers they may face when navigating criminal justice, behavioral health, and community-based settings. Barriers include working with authoritative figures, access to employment, family restoration, and understanding recovery pathway options.

### FORMAT:



*This training offers 24 hours that may be used towards certification (check with your state or certification board).*

Training is 4 full days offered virtually or in person and can include state specific modules.

- Domains covered include Criminal Justice: Mentoring and Education, Recovery and Wellness, Advocacy, and Ethical Responsibility.

### WHO SHOULD BECOME A CERTIFIED TRAINER:

SAFE Project's i-FPRS ToT trains participants who work with individuals who are justice-involved across a variety of settings (jails and prisons, reentry programs, community-based programs, treatment programs, probation offices, psychiatric settings, etc.).

Participants who complete the ToT will be positioned to deliver the i-FPRS training to Peer Recovery Specialists and supervisors within their state.

### REQUIREMENT:

- Working knowledge of the peer recovery support scope of practice

Funding for this ToT may be available through your state's Peer Recovery Specialists Certification Board, state behavioral health administration, local health departments, and/or recovery community organizations.
